HealthCare Key Challenges

PATHOLOGY'S EVOLUTION

In aging Europe, we can see a clear evolution pattern, moving from acute towards chronic pathologies. The whole healthcare system must change to address this challenge.

ECONOMIC STRAINS

Quality of care is under pressure due to hospitalization time reduction, care staffing reduction, together with a generic social security and health cost cutting

The Health Information System (HIS) including Patient Record needs to evolve towards multiple data sources, medical algorithms (big data, deep learning or AI) and mobile health.

Intra-muros hospital is slowly fading down as hospitalization@home is growing together with care actors operating outside the hospital thanks to telemedecine, e- and m-health.






